SUPPLEMENT TO THE DECLARATION OF CONDOMINIUM FOR PARKSIDE AT HERRIMAN TOWN CENTER CONDOMINIUMS

E AT TIERTIMAN TOWN CENTER CONDOMINATION

An Expandable Utah Condominium Project (Phase 3 Plat 'L')

This Supplement to the Declaration of Condominium for Parkside at Herriman Town Center Condominiums ("Supplemental Declaration") is executed and adopted by Edge Parkside at HTC, LLC, a Utah limited liability company ("Declarant").

RECITALS

- A. This Supplemental Declaration shall modify and supplement the Declaration of Condominium for Parkside at Herriman Town Center Condominiums recorded with the Salt Lake County Recorder's Office on May 14, 2020 as Entry No. 13269987 ("Declaration").
- B. Edge Parkside at HTC, LLC is the Declarant as identified and set forth in the Declaration and is the owner of the real property subject to this Supplemental Declaration.
- C. Under the terms of the Declaration, Declarant reserved the right to expand the Property by the addition of all or a portion of the Additional Land including but not limited to Additional Land described in the Declaration.
- D. Declarant desires to add a portion of the Additional Land described in the Declaration as hereinafter provided for.

ANNEXATION

NOW THEREFORE, in consideration of the recitals set forth above, the Declarant hereby declares and certifies as follows:

- 1. Annexation of Additional Land. Declarant hereby confirms that all of the real property identified on Exhibit A attached hereto, together with (i) all buildings, improvements, and structures situated on or comprising a part of the above-described real property, whether now existing or hereafter constructed; (ii) all easements, rights-of-way, and other appurtenances and rights incident to, appurtenant to, or accompanying said real property; and (iii) all articles of personal property intended for use in connection therewith (collectively referred to herein as the "Subject Property") is submitted to and properly annexed into the Declaration.
- 2. Phase 3 Plat 'L' Map. The real properties described in Paragraph 1, and the improvements to be constructed thereon, all of which are submitted to the terms and conditions of the Declaration, are more particularly set forth on the **Parkside at Herriman Town Center Phase 3 Plat 'L' Condominium** plat map, which plat map shall be recorded with this Supplemental Declaration.

- 3. <u>Submission</u>. The Subject Property shall hereinafter be held, transferred, sold, conveyed, and occupied subject to the covenants, restrictions, easements, charges, and liens set forth in the Declaration and all supplements and amendments thereto.
- 4. <u>Membership</u>. The Owner of each Unit within the Subject Property shall be a member of the Parkside at Herriman Town Center Condominium Association.
- 5. <u>Master Association Membership</u>. the Owner of each Unit within the Subject Property shall also be a member of the Parkside at Herriman Town Center Common Association and shall be entitled to all benefits of such membership and shall be subject to the Declaration of Covenants, Conditions, and Restrictions for Parkside at Herriman Town Center recorded in the Salt Lake County Recorder's Office.
- 6. <u>Allocated Interests</u>. The Allocated Interests in Common Areas as set forth on Exhibit B of the Declaration and all Supplements to the Declaration recorded prior to the recording of this Supplemental Declaration shall be amended and restated as set forth in Exhibit B attached hereto.
- 7. <u>Reservation of Declarant's Rights.</u> Pursuant to the Declaration, all rights concerning the Project reserved to Declarant in the Declaration are hereby incorporated and reserved to Declarant with respect to the Subject Property. The exercise of Declarant's rights concerning such Subject Property shall be governed by the terms, provisions and limitations set forth in the Declaration.
- 8. <u>Effective Date</u>. This Supplemental Declaration shall take effect upon being recorded with the Salt Lake County Recorder.
