**AN ORDINANCE**  
AN ORDINANCE vacating the North 19.5 feet of 12th Avenue between 'J' and 'K' Streets in Salt Lake City, Utah. Be it ordained by the Board of Commissioners of Salt Lake City, Utah.

**SECTION 1.** That the North 19.5 feet of 12th Avenue between 'J' and 'K' Streets, more particularly described as follows:

Beginning at the southwest corner of Lot 2, Block 172, Plat 'D', Salt Lake City Survey, running thence East 330 ft to southeast corner of Lot 1, said Block 172; thence south 19.5 ft; thence west 330 ft; thence north 19.5 ft to point of beginning.

be and the same is hereby vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way.

Said vacation is made expressly subject to all existing rights-of-way and easements of all public utilities of any and every description now located in, on, under or over the confines of the above described property; and also subject to the rights of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or re-routing said utilities and all of them.

**SECTION 2** In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

**SECTION 3** This ordinance shall take effect upon its first publication.
