AN ORDINANCE

AN ORDINANCE vacating the North
19.5 ft. of 12th Avenue between 'I'
and 'K' Streets, Salt Lake City, Utah.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah,

SECTION 1. That the North 19.5 ft.

of 12th Avenue between 'I' and 'K'

Streets, more particularly described

as follows:

Beginning at the southwest corner

of Lot 2, Block 172, Plat 'D', Salt

Lake City, thence North 19.5 ft., thence

East 330 ft. to southeast corner of

Lot 1, said Block 172; thence south

19.5 ft. to beginning of it; thence

north 19.5 ft. to point of beginning;

be and the same is hereby vacated and

declared to be public property

for use as a street, avenue, alley

or pedestrian way.

Said property is made expressly sub-

ject to all existing rights, easements

and covenants of all public utilities of any

kind, description now located in,

under or over the surface of the

above described property; and also

subject to the rights of entry thereon

for the purpose of inspecting, main-

aining, repairing, replacing, remov-

ing and/or re-routing said utilities

and all other rights.

SECTION 2. In the opinion of the

Board of Commissioners, it is neces-

sary to the general welfare and safety

of the inhabitants of Salt Lake City

that this ordinance shall become ef-

fective immediately.

SECTION 3. This ordinance shall take

effect upon its first publication.
