From and after the recordation of this Supplement, the Additional Land shall be held, transferred, sold, conveyed and occupied subject to the Declaration, including, without limitation, all covenants, restrictions, easements, conditions, charges, and liens set forth in the Declaration. In addition, the Additional Land shall be subject to the governance of the Daybreak Highland Park Village Townhome Association, Inc., a Utah nonprofit corporation, as more particularly described in the Declaration.
- **Full Force and Effect**. The Declaration, as amended hereby, remains in full force and effect.
