The Court after review of the pleadings on the motion to set aside judgment, hereby grants the same. The Court determines there are genuine issues that need to be litigated, rather than one party simply prevailing and gaining a windfall due to Defendant's failures. Further, there appears to be a defense to this matter.
