The undersigned, being all of the members of the Board of Directors (the "Board") of the Bingham Point Owners Association, Inc. (the "Association"), held a meeting on January 25, 2021, to consider the following resolution:

Revising the Reinvestment Fee

WHEREAS, the Board has authority pursuant to Section 21.1 of the Declaration of Covenants, Conditions, Easements and Restrictions of Bingham Point ("CC&Rs) to revise the Reinvestment Fee (as defined therein); and

WHEREAS, the Board deems it in the best interest of the Association to modify the Reinvestment Fee as described below;

NOW, THEREFORE, BE IT RESOLVED that the Reinvestment Fee as defined in the CC&Rs, is hereby increased to Nine Hundred Dollars (\$900.00), to be effective February 1, 2021.

Amending the Reinvestment Fee Covenant

BE IT RESOLVED, that Section 21.1 of the Declaration of Covenants, Conditions, Easements and Restrictions of Bingham Point (a 55 & Older Community located in West Valley City, Utah) is hereby amended and restated in its entirety as follows:

21. REINVESTMENT FEE COVENANT.

21.1 With respect to each and every conveyance of title to an individual Unit to a new Owner in the Bingham Point Owners Association, Inc., after February 1, 2021, a fee in the amount of Nine Hundred Dollars (\$900.00) (the "Reinvestment Fee") shall be paid by the buyer of the Unit to the Association. The Board has the authority, by written resolution, to modify the amount of the Reinvestment Fee, according to the financial needs of the Association. To the fullest extent practical, the Reinvestment Fee shall be collected at the closing of the purchase by the title company, escrow company, or other persons involved with the transaction, and paid directly to the Association.

Miscellaneous

RESOLVED, that the officers of the Association (each, an "Authorized Officer") be, and each of them individually hereby is, authorized and empowered to do and perform or cause to be done and performed all such acts, deeds and things, and to make, execute and deliver, or cause to be made, executed and delivered, all such agreements, undertakings, documents, instruments or certificates in the name of the Association and to retain such counsel, agents and advisors and to incur and pay such expenses, fees and taxes as shall, in the opinion of the officers of the Association executing the same, be deemed necessary or advisable (such necessity or advisability to be conclusively evidenced by the execution thereof) to effectuate or carry out fully the purpose and interest of all of the foregoing resolutions; and that any and all such actions heretofore or hereafter taken by the Authorized Officers relating to and within the terms of these resolutions be, and they hereby are, adopted, affirmed, approved and ratified in all respects as the act and deed of the Association; and

RESOLVED, that an executed company of this Consent be filed with the minutes of the proceedings of the Board.

This Written Consent may be signed in two or more counterparts, each of which shall be deemed an original, and shall be deemed one instrument.
