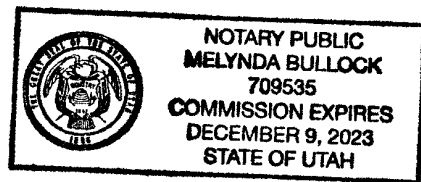

Thence along the west R.O.W. line of Memory Lane the following four calls, Thence South 00° 00' 59" East a distance of 38.90 feet, Thence South 44° 45' 59" East a distance of 929.25 feet, Thence South 46° 48' 01" West a distance of 200.20 feet to the beginning of a curve, Said curve bears to the left through an angle of 22° 41' 51", having a radius of 127.34 feet along the arc a distance of 50.45 feet, and whose long chord bears South 35° 27' 05" West a distance of 50.12 feet to a point of intersection with a non-tangential line. Thence North 65° 53' 50" West a distance of 10.00 feet to the beginning of a non-tangential curve, Said curve bears to the left through an angle of 15° 27' 32", having a radius of 137.34 feet along the arc a distance of 37.06 feet, and whose long chord bears South 16° 22' 24" West a distance of 36.94 feet to a point of intersection with a non-tangential line. Thence North 41° 18' 43" West a distance of 298.43 feet, Thence North 41° 18' 43" West a distance of 588.78 feet, Thence North 76° 26' 18" West a distance of 265.41 feet, Thence North 03° 12' 35" West a distance of 120.10 feet to the beginning of a non-tangential curve, Said curve bears to the right through an angle of 12° 01' 14", having a radius of 101.33 feet along the arc a distance of 21.26 feet, and whose long chord bears North 02° 43' 04" East a distance of 21.22 feet to a point of intersection with a non-tangential line, Thence North 08° 48' 26" East a distance of 16.40 feet to the beginning of a non-tangential curve, Said curve bears to the left through an angle of 11° 58' 20", having a radius of 99.35 feet along the arc a distance of 20.76 feet, and whose long chord bears North 02° 45' 34" East a distance of 20.72 feet to a point of intersection with a non-tangential line.
