OPEN SPACE DEDICATION DEED

With Easement Reservation

(Salt Lake County, Utah)

OLYMPIA RANCH, LLC, a Utah limited liability company ("Grantor"), for valuable consideration, hereby conveys, dedicates, and warrants against all claiming by, through or under it, but not otherwise, to **HERRIMAN CITY**, a municipal corporation and political subdivision of the State of Utah ("Grantee") the following described real property located in Salt Lake County, State of Utah (the "Property"):

See Legal Description attached as Exhibit A and incorporated herein. A map depicting the location and boundaries of the Property is also attached as Exhibit A hereto.

Subject to all easements, rights of way, and encumbrances of record, and also subject to the easement reserved below.

Reservation of Easement. In dedicating and granting the Property to Grantee, Grantor, for itself, its assignees/designees, its successors-in-interest, and its affiliates, including, without limitation, Teton Ranch, LLC, a Utah limited liability company (collectively, the "Easement Holders"), hereby expressly reserves on, in, under, above, and through all of the Property described in Exhibit A hereto (the "Easement Property"), for the benefit and use of the Easement Holders, a blanket easement covering all of the Easement Property with access, construction, and improvement rights for the following purposes:

- (i) To construct, install, repair, maintain, access, and replace, as needed, any and all "wet" and "dry" utility lines, underground pipes, surface-level improvements, roadways, and other infrastructure needed to support or facilitate development of any other real property owned, controlled, or developed by one or more of the Easement Holders in Salt Lake County, Utah; and
- (ii) To design, construct, install, improve, repair, access and replace, as needed, culinary and secondary/irrigation water lines, storm water detention or retention facilities, storm drain improvements, water storage tanks, water treatment facilities, and any other improvements that may be reasonably necessary or useful to support or facilitate development of any other real property owned, controlled, or developed by one or more of the Easement Holders in Salt Lake County, Utah.

For clarification, the Easement Holders shall not have the right to construct any residential dwellings or commercial buildings on or within the Easement Property.

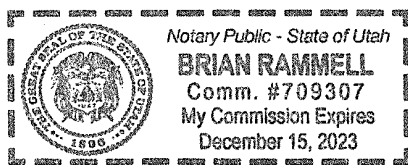
