2. No structure shall be erected, altered, placed or permitted to remain on any of said lots, other than one detached single family dwelling, not to exceed one story in height and a private garage for not more than two cars, one story in height.

3. No garage or any other buildings wintsoever stall be erected on any of said Lots, until a dwelling house shall have been erected or until a contract with a reliable and responsible contractor shall have been entered into for the construction of a dwelling which shall comply that the conditions, restrictions and stipulations herein contained; which shall comply with the conditions, restrictions and stipulations herein contained; and noither prior to the erection nor after the creation, of the main building herein permitted on any of said lots, shall any garage or other out building be used for
