PARTIAL ABANDONMENT OF EASEMENT

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, South Valley Sewer District hereby vacates and abandons a portion of the Easement to the owner or owners of the dominant tenement as the interest (s) of the owner (s) may appear. The portion(s) of the Easement hereby vacated and abandoned is located in Salt Lake County, Utah, and is more particularly described as follows:

Abandoned Sewer Easement Description:

A 20.00' wide strip of land being a portion of a 20.00' wide easement area in favor of South Valley Sewer District, recorded as Entry No.: 12426522, on file with the Salt Lake County Recorder's Office, situate within the Northeast Quarter of Section 07, Township 4 South, Range 1 West, Salt Lake Base and Meridian, located in Herriman City, County of Salt Lake State of Utah and being more particularly described as follows:

Beginning at a point of intersection with the Southeasterly Right-of-Way line of Daro Drive (4100 West Street), per the Bella Vea P.U.D.
