**AMENDED DECLARATION OF  
COVENANTS, CONDITIONS & RESTRICTIONS  
OF  
ROCKWELL RIDGE BUSINESS PARK**

THIS AMENDED DECLARATION of Covenants, Conditions and Restrictions ("CCRs") is made on the date hereinafter set forth for the project known as Rockwell Ridge Business Park in Bluffdale, Salt Lake County, State of Utah.

**RECITALS**

1. Parcels 1-6 and common area of the Rockwell Ridge Business Park situated in Bluffdale City, Salt Lake County, State of Utah, were developed by Rockwell Ridge Business Park, LLC which filed Restrictive Covenants on or about March 2, 2020 regarding the property described on the attached Exhibit together with common areas shown on the plat filed of record.

2. The CCRs gave the Developer/Declarant power to amend the Declarations pursuant to ¶12.01 of the Declaration recorded as Entry #13206295, Book #10903, Pages 7649-7675.

NOW, THEREFORE, by virtue of the authority granted the Developer/Declarant under the original CCRs, and pursuant to the authority of ¶12.01 of the original Declaration, the Developer/Declarant hereby amends that certain Declaration identified above as follows:

**EXHIBIT D  
PROHIBITED USES**

Virtual reality theme operations are no longer prohibited and are expressly allowed.

**ARTICLE II

To the extent this Amendment conflicts with the original Covenants, Conditions and Restrictions recorded, this Amendment shall govern.

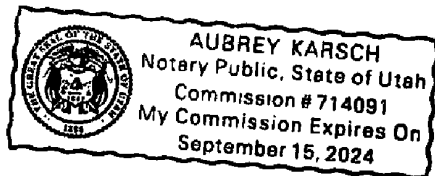
