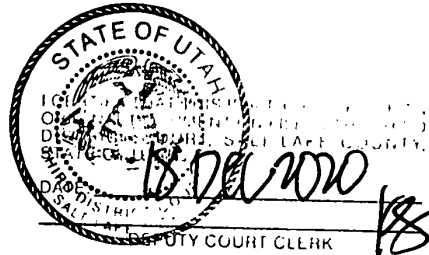

3. For a reasonable attorney's fee in the sum of \$250.00 pursuant to Rule 73 of the Utah Rules of Civil Procedure.

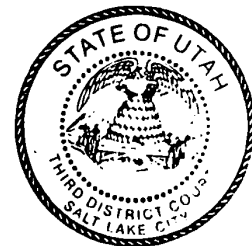
