RELEASE

WHEREAS on or about September 29, 1950, Leonard D. Gardner, Heber G. Taylor, and Ted C. Jacobsen entered into a certain agreement with The Country Club, a Utah corporation, involving a mutual boundary line along or 12 feet South of the quarter section line of Section 22, Township 1 South, Range 1 East, Salt Lake Base and Meridian, which agreement resulted from a compromise of pending litigation docketed as Civil No. 85970 at the office of the Clerk of the Third Judicial District Court in and for Salt Lake County, Utah, and

WHEREAS the undersigned, W. S. MOLE and MYRIAL D. MOLE, his wife, are successors in interest of the said Leonard D. Gardner, Heber G. Taylor, and Ted C. Jacobsen, and


WHEREAS such dispute was compromised and settled by the agreement above mentioned,

NOW, THEREFORE, the undersigned in conformity with said agreement, hereby release The Country Club, a Utah corporation, and all persons engaged in playing golf upon said course owned and occupied by The Country Club from any liability for personal injury to themselves, their successors, or assigns arising from the use of said golf course by the members of The Country Club or persons playing golf upon said course, and do further release such persons from any and all liability for property damage arising from said use of said premises; on condition, however, that the aforesaid personal injury or property damage results directly or indirectly from lack of fences along the mutual boundary line.

IT IS UNDERSTOOD AND AGREED that this release is based upon the consideration existing in that certain contract above referred to, and further upon the consideration that The Country Club would not build and maintain fences between the properties occupied by the undersigned and The Country Club.


IT IS ACKNOWLEDGED by the undersigned that the erection of such fences would be detrimental to the use and enjoyment of the property owned and occupied by the undersigned.

IT IS FURTHER UNDERSTOOD that this release shall be binding upon the heirs, administrators, executors, successors and assigns of the undersigned.
