THIS DEED WITNESSES that Samuel Brinton and Joan Brinton, his wife grantors of Oakley in the County of Summit State of Utah, hereby convey and warrant to The Rio Grande Western Railway Company, a corporation of the State of Utah and State of Colorado, for the sum of Sixty One and 25/100 Dollars, the following described tract of land in the County of Salt Lake and State of Utah, to-wit: A strip of land in Southeast 1/4 of Section 1, Township 2 South, Range 1 West, on the Easterly side and adjoining the present right of way along the main line of The Rio Grande Western Railway, and the spur to the Hanauer Smelter, described as follows:

Beginning at the intersection of the South line of grantors land with the East boundary line of the present right of way along the main line of The Rio Grande Western Railway, said point being 1431 feet West and 964 feet South from the Northeast corner of the Southeast 1/4 of said section 1, thence running East along the South boundary of grantors land 48 feet, thence N. 4° 23' W. parallel with and 50 feet from the center line of the changed main line as now located 205 feet, thence Northeasterly on a curve to right, parallel with and 16 1/2 feet distant from the center line of the changed spur to Hanauer Smelter 348 feet to the present right of way, thence along the present right of way of said spur S. 55° 08' W. 63 feet, thence on a curve to left 284 feet to the right of way boundary of the main line, thence following the present boundary of main line right of way, S. 0° 36' E. 238 feet to the place of beginning, containing 0.35 acres.

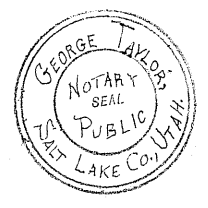
