

RIGHT-OF-WAY DEED

Beginning at a point which is South 11° 45' West 300 feet and thence South 65° 19' East 100 feet from the Northwest corner (No. 1) of said Dickinson Claim; and running thence South 11° 45' West 10 feet; thence South 65° 19' East 115 feet; thence North 11° 45' East 10 feet; thence North 65° 19' West 115 feet to the point of beginning.

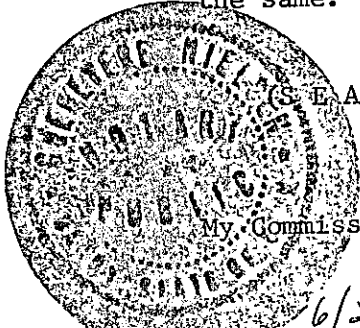
