This matter came on regularly before the above-entitled Court pursuant to plaintiff's Stipulation. Based upon the Declaration of Non-Compliance filed herewith, and the Court being otherwise advised in the premises, it is hereby

ORDERED, ADJUDGED AND DECREED that Plaintiff shall have a Judgment against Defendants, Demetrius Taylor and Shay Taylor, as follows:

1. For Judgment in the principal sum of \$9,232.96, together with interest accrued at the contractual rate of 13.24% from and after November 29, 2018 in the amount of \$3,026.36, together with Collection Fees in the sum of \$468.72 (late fees in the amount of \$123.72, together with NSF fee in the amount of \$20.00, Repossession fee in the amount of \$325.00), less payments made prior to August

29, 2022 in the amount of \$500.00.

2. For plaintiff's cost incurred herein in the sum of \$410.00.
3. For a reasonable attorney's fee in the sum of \$750.00 pursuant to Rule 73 of the Utah Rules of Civil Procedure. Counsel for Plaintiff will comply with Utah Rule of Professional Conduct 5.4 and will not share legal fees..

The total Judgment **\$13,388.04** shall bear interest at the rate of **2.29%** per annum until paid in full.

The judgment may be augmented in the amount of reasonable costs expended in collecting said judgment by execution or otherwise as shall be established by declaration.

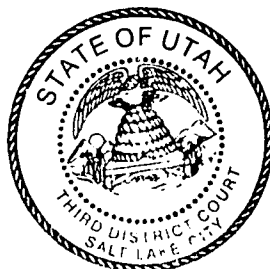
