### TRUSTEE'S DEED

Pursuant to its powers and authorities under the Trust Deed and the power of sale as set forth in Utah Code § 57-1-1 *et seq.* (the "Act"), RSVP Holdings, LLC (the "Grantor"), as beneficiary and a secured party under the Trust Deed, hereby grants and coveys title to itself, **RSVP Holdings, LLC** (the "Grantee"), WITHOUT any covenant or warranty, express or implied and SUBJECT TO any other lien or encumbrance with priority to the Trust Deed, all of the real property located at 3861 East Evelyn Drive, Millcreek, UT 84124, ("the Property"), and more particularly described as:

This grant and conveyance are made after the fulfillment of the conditions specified in the Trust Deed Act, described as follows:

- 1) Corbin W. Archer and Lisa A. Archer, record-owner of the Property, breached their obligations under the Trust Deed by failing to pay amounts owing the Lender.
- 2) On April 7, 2022, Lender appointed a Trustee for purposes of foreclosing on the Trust Deed against the Property in accordance with the Act. The Substitution of Trustee was filed with the Salt Lake County Recorder's Office as Entry No. 13928564.
- 3) On April 7, 2022, the Trustee caused a Notice of Default and Election to Sell, as prescribed by applicable statute, to be recorded in the office of Salt Lake County Recorder, as Entry No. 13928565, and required copies were sent to all persons entitled to notice in accordance with the provisions of applicable statute.

- 4) At least three (3) months elapsed after the filing of said Notice of Default and Election to Sell, at which time the Grantor executed a Notice of Sale stating that Grantor would sell at public auction to the highest bidder the Property, described above. The Notice of Sale was posted and advertised as required by law. Said Notice of Sale fixed the time and place of the sale as the East Rotunda, Matheson Courthouse at 450 South State Street, Salt Lake City, UT 84114 on August 29, 2022, at 10:00 AM.
- 5) Borrowers Corbin W. Archer and Lisa A. Archer filed for Chapter 13 bankruptcy protection on August 26, 2022 to stop the August foreclosure sale. This case was subsequently dismissed on October 12, 2022 for failure to file required information.
- 6) Thereafter, Lender re-noticed the sale stating that Grantor would sell at public auction to the highest bidder the Property, described above. The Notice of Sale was posted and advertised as required by law. Said Notice of Sale fixed the time and place of the sale as the East Rotunda, Matheson Courthouse at 450 South State Street, Salt Lake City, UT 84114 on November 16, 2022, at 10:00 AM.
- 7) Borrowers Corbin W. Archer and Lisa A. Archer again filed for Chapter 13 bankruptcy protection on November 16, 2022 to attempt to stop the new November foreclosure sale.
- 8) Pursuant to Utah Code 57-1-27, the Trustee, by public announcement, postponed the sale from November 16, 2022 to December 29, 2022 at 10:00 AM, again to occur at the East Rotunda, Matheson Courthouse at 450 South State Street, Salt Lake City, UT 84114.
- 9) On November 17, 2022, the Honorable Judge Kevin R. Anderson of the U.S. Bankruptcy Court for the District of Utah issued an Order confirming that, pursuant to 11 U.S.C. § 362(c)(4)(A)(ii), "there is no automatic stay in effect as to Debtors Corbin William Archer and Lisa Ann Collet Archer or their property."
- 10) Therefore, the Grantor, at the time and place of sale fixed in accordance with the foregoing Notice of Sale which sale was postponed to December 29, 2022, at 10:00 AM, then and there offered the Property to be sold to the highest bidder at a public auction. However, no bidders other than the Lender attended the sale, and the Lender now takes title pursuant to the Deed of Trust and the Act.
- 11) RSVP Holdings, LLC hereby reserves its rights to pursue a deficiency judgment against Borrowers Corbin W. Archer and Lisa A. Archer in accordance with applicable law.


