AGREEMENT EXTENDING RESERVATIONS, RESTRICTIONS
AND COVENANTS

COME NOW the undersigned record owners of lots in that certain subdivision known as "Cottonwood Glade Subdivision", according to the official plat thereof on record in the office of the Salt Lake County Recorder, and do hereby mutually agree that those certain reservations, restrictions and covenants relating to said subdivision, dated December 26, 1947, executed by Cyrene N. Bagley, et al, recorded December 26, 1947, be and the same are hereby extended and amended in the following particulars:

Paragraph III relating to the approval of building plans, specifications and plot plan prior to the construction or alteration of dwellings upon said property is hereby extended beyond January 1, 1955 to and including January 1, 1965, and the following persons are designated as a committee to act in pursuance of the provisions of said Paragraph III for the approval or disapproval of such design and location, to-wit: Edward N. Bagley, Harold H. Gloe, and Glen C. Peglau.

All of the rest and residue of said reservations, restrictions, and covenants shall continue in full force and effect.
