Mascaro, an individual, and Mascaro Transport, LLC, a Utah Limited Liability Company (collectively "Defendants"). It appearing to the Court that Defendants have each been properly served with a copy of the Complaint and Summons; and it appearing that Defendants have failed to appear and answer the complaint on file herein, or otherwise plead; and it appearing that the time for response has expired; and it appearing that the default of both Defendants has been entered; and it further appearing that Plaintiff is entitled to default judgment against Defendants, it is hereby 00000000

ORDERED that judgment be entered in this action in favor of Plaintiff and against Jacob A. Mascaro and Mascaro Transport, LLC, jointly and severally as follows:

1. An award in the amount of **\$41,198.33**, consisting of: \$38,000 in principal, plus pre-judgment interest of \$3,198.33 (as of 9/8/2022), *less* payments made of \$0.
2. Post-judgment interest shall accrue at the default rate of interest per Utah Code § 15-1-4 of 2.29% per annum until paid in full.
