

Judgment Against Defendant Bryan W. Lund Upon Confession, and GOOD CAUSE appearing
therefore, it is hereby

ORDERED, ADJUDGED, and DECREED that plaintiff Covington Capital Corporation shall
have an Order and Judgment against defendant Bryan W. Lund of \$440,000 (Four Hundred

Forty-Thousand Dollars and No Cents), together with interest at 9% per annum from December 1, 2020, and continuing thereafter until paid in full by Bryan W. Lund, minus any amounts that may have been paid under the terms stated at the time of entry of an Order and Judgment.
