State Street, Murray, County of Salt Lake, State of Utah, for the sum of TEN (\$10.00) Dollars, a temporary construction easement, with the rights of ingress, egress, installation, removal, and abandonment of utilities, upon part of an entire tract of property situate in the SE 1/4 of Section 11, T.2S., R.1W., S.L.B.&M., in Salt Lake County, Utah.

The Grantee agrees to:

1. Minimize disturbance within the work area and restore the area disturbed.
2. Not allow the construction contractor to store or dispose of any excavated or graded soil or organic material on Grantors's property unless contractor has made a separate agreement with the Grantor.

This temporary construction easement is for the purpose of installing, repairing, removing, and abandoning utility facilities. This easement shall commence upon the beginning of actual construction on the property and shall continue only until project construction on the property is complete, or for one year, whichever first occurs.

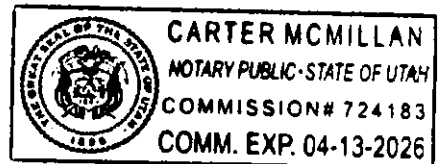
