Defendants David L. Fisher (“Fisher”), Fisher Law Group, PLLC (“Fisher Law Group”), Mikas Law Group, PLLC (“Mikas”), and Vannova Legal, PLLC (“Vannova”) having been duly served with a Summons and Complaint and the Default Certificate having been entered by the Clerk of this Court or by Order of this Court, and failing to plead or otherwise appear and defend against Plaintiff Wayne Sharp’s Complaint, and the legal time for Defendants Fisher, Mikas, and

Vannova to answer the Complaint or otherwise appear has expired, and after the entry of the order striking Defendant Fisher Law Group's Answer for failure to defend, upon the application of Plaintiff Wayne Sharp, IT IS HEREBY ORDERED AND ADJUDGED that the Plaintiff is awarded judgment against the Defendants, as follows:
