### ASSIGNMENT AGREEMENT

This Assignment Agreement is made on April 30, 1986, between Acorn Hills Water Corporation, a Utah corporation (hereinafter "Acorn Hills") and Young Oak Water Corporation, a Utah corporation (hereinafter "Young Oak").

### RECITALS

WHEREAS, Acorn Hills was incorporated in 1980 for the purpose of operating as the Acorn Hills Water Association to own the water rights relating to up to 14 lots in the Acorn Hills Subdivision in Emigration Canyon, Salt Lake County, Utah; and

WHEREAS, Acorn Hills has received valid assignments from the previous owners thereof of all the water rights necessary to provide water to homes on each of the 14 lots which are members of the Acorn Hills Water Association (such water rights are identified on Appendix I, hereto); and

WHEREAS, the Acorn Hills corporate entity has been suspended by the State of Utah for failure to file franchise tax returns and for failure to file necessary annual reports; and

WHEREAS, due to the expense which would be necessary to reinstate the Acorn Hills corporate entity, a new corporate

entity called Young Oak Water Corporation has been formed for the purpose of assuming the functions of the water association for the above-mentioned 14 lots and homes thereon; and

WHEREAS, the officers and trustees of Acorn Hills are desirous of transferring, assigning and conveying all rights, title and interest it has in the above-mentioned water rights, including all other assets and liabilities, to Young Oak to allow Young Oak to operate in the future as the water association for such 14 lots and homes thereon;

NOW, THEREFORE, for good and valuable consideration, including the acceptance by Young Oak of all assets and liabilities of Acorn Hills and the duties of operating the water association in the future, the sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. The undersigned officers and trustees of Acorn Hills, by and on behalf of Acorn Hills Water Corporation, hereby irrevocably agree to assign and convey to Young Oak, its successors and assigns, all and singular, all assets and liabilities which Acorn Hills presently has, including all water rights which have previously been assigned to Acorn Hills (which water rights are identified on Appendix I, hereto), which assignment shall be made effective as of the date first set forth above.

- 2. The officers and trustees believe that the water rights transferred hereby to Young Oak Water Corporation (see Appendix I) are sufficient for the culinary needs of the owners of the 14 lots in the Acorn Hills Subdivision.
- Acorn Hills of all of its assets and liabilities, including the water rights identified in Appendix I hereto, and hereby agrees to henceforth operate the Young Oak Water Corporation as'a water association for the owner's of the 14 lots, and homes thereon, in the Acorn Hills Subdivision. By acceptance of this assignment, Young Oak assumes the performance of all the duties and obligations of Acorn Hills as such water association and with respect to such water rights.
- 4. The parties agree that this Agreement may be signed by the various parties in counterparts and the various copies or counterparts so signed shall constitute the entire Agreement.
