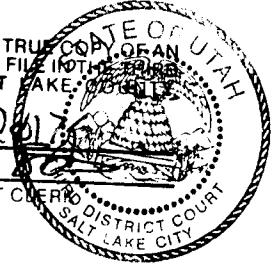

IN THIS ACTION, the defendant Jeff Johnson dba Johnson Equipment Solutions (“Johnson”), having been regularly served with process, and having failed to appear and answer plaintiff Love Machine Company Incorporated, The (collectively “Love Machine”) complaint filed herein, the legal time for answering having expired, and the default of Johnson in the premises having been duly entered according to law, now upon the application of Love Machine to the above-entitled court, judgment is hereby entered against Johnson in pursuance of the prayer of said

complaint.

WHEREFORE, it is ordered, adjudged, and decreed that Love Machine recover from Johnson the sum of \$1,192.96, together with a service charge in the amount of \$20.00, together with interest at the highest legal rate from March 20, 2015 until paid, currently in the amount of \$222.77, together with damages in the amount of \$500.00, together with court costs and service fees in the amount of \$145.00, together with attorney fees in the amount of \$260.00, for a total judgment of **\$2,340.73**.

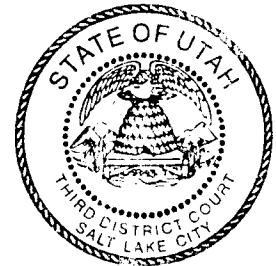
