EXHIBIT "A"

A Temporary Easement granted in Quit-Claim Deed #18134, Book 1345, Page 767, described in deed as follows:

Commencing at a point 1974.23 feet North and 694.77 feet East from the South one-quarter corner of Section 35, Township 6 South, Range 2 East, Salt Lake Base and Meridian; thence North $0^{\circ}30'$ West along a fence line 655.3 feet more or less to the South street line of 1460 North Street; thence South $88^{\circ}23'$ East along the street line 16.5 feet; thence South $0^{\circ}30'$ East 655.3 feet more or less to a point due East of the point of beginning; thence East 16.5 feet to the point of beginning.

Said property is described by actual survey as follows:

Commencing at a point located North $89^{\circ}36'46"$ West along the one-quarter section line 1970.15 feet and South 14.53 feet from the East one-quarter corner of Section 35, Township 6 South, Range 2 East, Salt Lake Base and Meridian; thence South $2^{\circ}01'31"$ East 666.04 feet; thence South $89^{\circ}56'23"$ West 16.51 feet to the East boundary of Plat "A", "B", and "C", Hyview Subdivision; thence along said boundary North $2^{\circ}01'31"$ West 666.06 feet; thence South $89^{\circ}59'05"$ East 16.50 feet to the point of beginning.
