

**SUPPLEMENT TO THE  
DECLARATION OF CONDOMINIUM  
FOR MOUNTAIN RIDGE CONDOMINIUMS**

**An Expandable Utah Condominium  
(Phase 21 Plat BB)**

This Supplement to the Declaration of Condominium for Mountain Ridge Condominiums ("Supplemental Declaration") is made and executed by Edge Mountain Ridge, LLC and is effective as of the date it is recorded in the Salt Lake County Recorder's Office.

**RECITALS**

A. This Supplemental Declaration shall modify and supplement the Declaration of Condominium for Mountain Ridge Condominiums recorded on November 1, 2022 as Entry No. 14037274 in the Salt Lake County Recorder's Office ("Declaration").

B. Edge Mountain Ridge, LLC is the Declarant as identified and set forth in the Declaration.

C. Edge Mountain Ridge, LLC is the owner of the real property subject to this Supplemental Declaration and hereby consents to subjecting the Subject Property to the terms, covenants, and restrictions contained herein and those terms, covenants, and restrictions contained in the Declaration.

D. Under the terms of the Declaration, Declarant reserved the right to expand the Project by the addition of all or a portion of the Additional Land described in the Declaration. Declarant desires to add a portion of the Additional Land as hereinafter provided for.

E. Unless otherwise defined herein, capitalized terms shall have the same meaning as defined in the Declaration.

**ANNEXATION**

NOW THEREFORE, in consideration of the recitals set forth above, the Declarant hereby declares and certifies as follows:

1. Annexation of Additional Land. Declarant hereby confirms that all of the real property identified on Exhibit A attached hereto, together with (i) all buildings, improvements,

and structures situated on or comprising a part of the above-described real property, whether now existing or hereafter constructed; (ii) all easements, rights-of-way, and other appurtenances and rights incident to, appurtenant to, or accompanying said real property; and (iii) all articles of personal property intended for use in connection therewith (collectively referred to herein as the "**Subject Property**") is submitted to and properly annexed into the Declaration.

2. Plats. The real property described in Paragraph 1, and the improvements to be constructed thereon, all of which are submitted to the terms and conditions of the Declaration, are more particularly set forth on the following plat, which plat map is recorded in the office of the Salt Lake County Recorder:

3. Submission. The Subject Property shall hereinafter be held, transferred, sold, conveyed, and occupied subject to the covenants, restrictions, easements, charges, and liens set forth in the Declaration and all supplements and amendments thereto. The Subject Property shall be part of the condominium Project, which Project includes the real property situated in Salt Lake County described in Exhibit B, attached hereto, together with all buildings and improvements previously, now, or hereafter constructed, and all easements and rights appurtenant thereto.

4. Membership. The Owner of each Unit within the Subject Property shall be a member of the Mountain Ridge Condominium Association, and shall be entitled to all benefits of such membership and shall be subject to the Declaration. The Undivided Interest allocated to each Unit in the Common Areas, Common Expense Liability, and votes in the Association is set forth on Exhibit C attached hereto.

5. Reservation of Declarant's Rights. Pursuant to the Declaration, all rights concerning the Project reserved to Declarant in the Declaration are hereby incorporated and reserved to Declarant with respect to the Subject Property. The exercise of Declarant's rights concerning such Subject Property shall be governed by the terms, provisions, and limitations set forth in the Declaration.

6. Effective Date. This Supplemental Declaration shall take effect upon being recorded with the Salt Lake County Recorder.

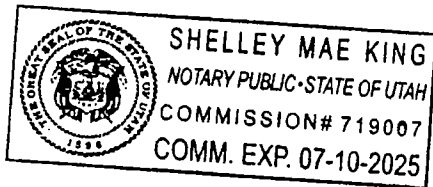
