Affiant, ARLENE JOYCE WELLS, being sworn, states that:

1. VIRGINIA V. ANDERSON is the Trustor of the VIRGINIA V. ANDERSON TRUST, dated JULY 13, 1992 (the "Trust"), and ARLENE JOYCE WELLS and VIRGINIA ALICE ANDERSON, or their survivor, are the initial Trustees of the Trust.

2. The real property located at 7027 Ponderosa Drive, Salt Lake City, Utah 84121 (Parcel ID 22-27-104-009) was conveyed to the Trust by Quit Claim Deed dated July 13, 1992 and recorded July 28, 1992 as entry number 5299555, Bk 6491, Pgs 0603-0604, and is more fully described as follows (the "Property"):

LOT 29, PONDORAY PARK SUBDIVISION NO.1 according to the official plat thereof filed in the office of the Salt Lake County Recorder, State of Utah.

3. ARLENE JOYCE WELLS resigned as Co-Trustee of the Trust by Affidavit of Resignation of Trustee dated October 3, 2008 and recorded October 8, 2008 as entry number 10537540, Bk 9649, Pgs 6690-6691.

4. VIRGINIA ALICE ANDERSON, the remaining Trustee of the Trust, died December 18, 2023, and a copy of the Certificate of Death, State File Number 2023021171, as registered in the Utah State Office of Vital Records and Statistics, is attached hereto.

5. Article VIII of the Trust appoints West One Bank, Salt Lake City, Utah as successor trustee of the Trust if ARLENE JOYCE WELLS and VIRGINIA ALICE ANDERSON resign or fail to act as Trustee. ARLENE JOYCE WELLS has resigned and VIRGINIA ALICE ANDERSON is deceased. By letter dated February 23, 2024, U.S. Bank, NA, successor to West One Bank, declined and renounced its right as successor trustee of the Trust, a copy of which letter is attached hereto.

7. Accordingly, Affiant, ARLENE JOYCE WELLS, Trustee of the Virginia V. Anderson Trust Dated July 13, 1992, is now the current owner in trust of the Property.






