Petitioner, Grace Ivory Rock nka Grace Ivory Campbell (“Grace”), by and through her attorneys of record, Christina Inge Miller and Zippy Ford, MILLER LAW GROUP, and Respondent, James Matthew Rock (“Jim”), by and through his attorney of record, Christian W. Clinger, hereby stipulate and agree to submit the following Order of Consolidated Judgments for the Court’s signature. This Order includes updated judgment amounts entered against Jim since December 1, 2022, with post-judgment interest accrued to date. As of November 20, 2023, Jim owes Grace the following judgment amounts:

1. Pursuant to the *Order on Motion to Enforce Orders and for Sanctions and Judgment* (Hearing: October 20, 2022), entered on December 1, 2022, the following judgments were entered against Jim and in favor of Grace:

- a. \$9,175.48 (from January 16, 2020 thru October 20, 2022) for Jim's failure to pay his half of school expenses to Grace;
- b. \$30,105.99 (from November 9, 2019 thru October 20, 2022) for Jim's failure to pay his half of the children's medical expenses and entire costs of children's medical premiums to Grace;
- c. \$4,000 (from November 2019 thru August 2020) for Jim's failure to pay his half of work-related childcare to Grace;
- d. \$8,187 (from October 6, 2021 thru October 20, 2022) for Jim's failure to pay child support to Grace;
- e. \$1,437 for Jim's failure to pay his half of fees owed to Guardian ad Litem Jill Coil, and
- f. \$430 (from March 1, 2021 through October 20, 2022) for Jim's failure to reimburse Grace for 100% of Dr. Goldsmith's costs.
- g. The entire judgment owing from Jim to Grace per this Order totals \$51,898.47¹. Judgment interest is accrued at 2.29% and as of November 20, 2023, the judgment interest is \$1,154.04 making the total **\$53,052.51**, and interest will continue accruing until paid in full.

¹ This amount only includes the judgments Jim owes to Grace, not the \$1,437 judgment owed by Jim to Guardian ad Litem Coil.

2. Pursuant to the *Order on Attorney Fees and Respondent's Rule 60(B) Motion and Judgment (Hearing: April 5, 2023)*, entered on May 18, 2023, a judgment was entered against Jim and in favor of Grace totaling \$55,708.50 for Grace's attorney fees, plus post judgment interest accruing until paid in full. Post judgment interest is accruing at 6.73%. The post judgment interest calculated from May 18, 2023 to the date of this Order (November 20, 2023) equals \$1,910.22. Accordingly, this judgment totals **\$57,618.72**, as of the date of this Order. Post judgment interest will continue accruing until this judgment has been paid in full.

3. Pursuant to the *Order on Petitioner's Motion to Enforce and Respondent's Counter Motion and Rule 102 Motion for Attorney Fees and Judgment (Hearing: June 13, 2023)*, entered on July 19, 2023, a judgment was entered against Jim and in favor of Grace for \$39,631.89 for Jim's inappropriate withdrawal of funds from his daughter's 529 account, plus post judgment interest accruing beginning July 19, 2023 until paid in full. Post judgment interest is accruing at 6.73%. The post judgment interest calculated from July 19, 2023 to the date of this Order (November 20, 2023) equals \$906.44. Accordingly, this judgment totals **\$40,538.33**, as of the date of this Order. Post judgment interest will continue accruing until this judgment has been paid in full.

4. Pursuant to the *Order of Attorney's Fees and Judgment*, entered July 15, 2023, a judgment was entered against Jim and in favor of Grace for \$1,338.50 for Grace's attorney fees, plus post judgment interest accruing from June 13, 2023 until paid in full. Post judgment interest is accruing at 6.73%. The post judgment interest calculated from June 13, 2023 to the date of this Order (November 20, 2023) equals \$40.00. Accordingly, this judgment totals **\$1,378.50**, as of the

date of this Order. Post judgment interest will continue accruing until this judgment has been paid in full.

5. Pursuant to the *Order of Attorney's Fees and Judgment*, entered September 7, 2023, a judgment was entered against Jim and in favor of Grace for \$6,521.50 for Grace's attorney fees, plus post judgment interest accruing from July 31, 2023 until paid in full. Post judgment interest is accruing at 6.73%. The post judgment interest calculated from July 31, 2023 to the date of this Order (November 20, 2023) equals \$134.40. Accordingly, this judgment totals **\$6,655.90**, as of the date of this Order. Post judgment interest will continue accruing until this judgment has been paid in full.

6. The total consolidated judgment amount owed by Jim to Grace (with the post judgment interest calculated through the date of this Order (November 20, 2023), not including the judgment owed to GAL Jill Coil), totals **\$159,243.96**. Post judgment interest will continue to accrue on this total.
