Bubo, LLC, a Utah Limited Liability Company, Grantor(s), hereby GRANTS AND CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, Grantee, at 4501 South 2700 West, Salt Lake City, Utah 84114, for the sum of TEN (\$10.00) Dollars, and other good and valuable considerations, the following described easement in Salt Lake County, State of Utah, to-wit:

A temporary easement, upon part of an entire tract of property, in the SW1/4 NW1/4 of Section 33, T.1S., R.1W., S.L.B.&M., in Salt Lake County, Utah, to facilitate the construction of roadway improvements, side treatments and appurtenant parts thereof and blending slopes, incident to the improvements of Lancer Way (3650 South Street) known as Project No. F-2215(1)0. This easement shall commence upon the beginning of actual construction on the property and shall continue only until project construction on the property is complete, or for three (3) years, whichever first occurs. The easement shall be non-exclusive such that the Grantor may use the property at any time in a manner which does not interfere with construction activities. The boundaries of said easement are described as follows:


Beginning at a point in the existing easterly right of way line of 3200 West Street which is 1,377.70 feet South along the section line and 33.00 feet East and 20.50 feet South from the Northwest Corner of said Section 33; and running thence N.89°55'29"E. 7.61 feet; thence N.51°15'53"E. 22.41 feet; thence N.89°55'29"E. 56.91 feet to the easterly boundary line of said entire tract; thence South 15.00 feet along said easterly boundary line; thence S.89°55'29"W. 7.89 feet; thence N.00°04'31"W. 7.00 feet; thence S.89°55'29"W. 47.50 feet; thence S.52°21'22"W. 24.60 feet; thence S.00°04'31"E. 2.50 feet; thence S.89°55'29"W. 7.12 feet to said easterly right of way line; thence North 11.50 feet along said easterly right of way line to the point of beginning. The above described easement contains 753 square feet or 0.017 acre in area, more or less.

(Note: Rotate all bearings in the above description 00°00'24" clockwise to obtain highway bearings.)
