NOTICE OF REINVESTMENT FEE COVENANT

(Rowhaus Condominiums and Rowhaus 2 Condominiums)

Pursuant to Utah Code Ann. §57-1-46(6), the Rowhaus Condominiums Homeowners' Association, Inc. ("the Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto, which is subject to the Amended and Restated Declaration of Covenants, Conditions, and Restrictions of Rowhaus Condominiums, recorded with the Salt Lake County Recorder on February 25, 2008 as Entry No. 10355738, and any amendments or supplements thereto (the "Declaration").
