Wilshire Circle, County of Salt Lake, State of Utah, Zip 84109, for the sum of TEN (\$10.00) Dollars, and other good and valuable considerations, the tract of land in Salt Lake County, State of Utah, to-wit:

A tract of land, situate in the NW1/4 NW1/4 of Section 36, T.1S., R.2W., S.L.B. & M. The boundaries of said tract of land are described as follows:


