**ORDER RE: MOTION TO RECONSIDER AND
PLAINTIFF'S MOTION FOR DEFAULT JUDGMENT**

THIS MATTER comes before the Court on the Motion to Reconsider Order Denying Motion for Default Judgment filed on March 15, 2024 ("Motion to Reconsider") and the attached exhibits. No response was filed. The Court, having considered the Motion, exhibits, the Court's file, the applicable law, and being otherwise fully advised in the premises, HEREBY GRANTS the Motion to Reconsider.

Based on the foregoing, the Court considers the Motion for Default Judgment filed by Plaintiff AP 3926-3930 Tennyson St., LLC, a Delaware limited liability company ("Plaintiff" or "Landlord") on February 2, 2024 ("Motion"), against Defendants Meraki Ventures Highlands LLC ("Tenant"), Brody King, Carl Crosser, and Nate Fennell (the "Individual Defendants") (collectively, "Defendants"). No response was filed. The Court held an in person hearing on May 29, 2024, during which an offer of proof was made by David Laird, Plaintiff's counsel, and during which Morgan Sowell, a representative for Plaintiff entity, testified. Defendants did not appear. The Court finds the offer of proof of Mr. Laird and testimony Mr. Sowell to be credible applying the standards regarding credibility contained in CJI 3:16 of the Colorado Pattern Civil Jury Instructions.

The Court, considering the Motion, attached exhibits, the Court's file, applicable law and being otherwise fully advised in the premises, hereby FINDS, ORDERS, and CONCLUDES as follows:

1. C.R.C.P. 55 provides that when a party against whom judgment for affirmative relief is sought has failed to defend as required by the procedural rules, judgment by default shall be entered against the party. *Bettcher v. State ex rel. Attorney General*, 344 P.2d 969, 971 (Colo. 1959).

2. Plaintiff filed this action against Defendants on September 13, 2023. Plaintiff asserts that Defendants are liable for damages for unpaid rent due to Plaintiff for the lease of the real property located at 3926 Tennyson Street, Dener, Colorado 80212 (the "Premises").

3. On October 17, 2023, Plaintiff appeared before the Court at a possession return hearing and the Court entered its Order awarding Plaintiff possession of the Premises.

4. Plaintiff filed this Motion for Default Judgment pursuant to C.R.C.P. 55(b) and C.R.C.P. 121 § 1-14 against Defendants. All of the requirements set forth in Rule 121 § 1-14(1)(a)-(d) have been met with respect to Defendants, as follows:

- a. On September 21, 2023, Plaintiff personally served Tenant's registered agent, Kate Tilby, and the Individual Defendants were personally served on either September 22 and 23, 2023 individually and as owners of Tenant with copies of the Complaint in Unlawful Detainer and for Damages, Exhibits 1-4 to the Complaint, a Summons in Unlawful Detainer, the Civil Cover Sheet, Blank Answer Form, Request for Documents Form, Fee Waiver Form, and an Eviction Information Form.
- b. Plaintiff has complied with C.R.C.P. 4.
- c. Defendants have failed to answer or otherwise respond to the Complaint within the required time. Tenant was served in Colorado on September 21, 2023. Pursuant to C.R.C.P. 12(a)(1), Tenant had twenty-one days after receipt of service to file responsive pleadings, or until October 12, 2023. The Individual Defendants were served in Utah on either September 22 or 23, 2023. Pursuant to C.R.C.P 12(a)(2), the Individual Defendants had thirty-five days from the of receipt of service to submit a responsive pleading – that is, on or before either October 27 or 28, 2023. No responsive pleading has been filed. Therefore, Defendants are in default, and Plaintiff is entitled to have default judgment entered in its favor against Defendants pursuant to C.R.C.P. 55(b).
- d. Venue is proper in this Court pursuant to C.R.C.P. 98(a) as the Premises is situated in the City and County of Denver, Colorado.
- e. On the basis of reasonable inquiry, Tenant, as a Colorado limited liability company, is not a minor, incapacitated person, officer, or agent of the state of Colorado, or an individual in the military service.
- f. On the basis of reasonable inquiry, Brody King is not a minor, incapacitated person, officer, or agent of the state of Colorado, or an individual in the military service.
- g. On the basis of reasonable inquiry, Carl Crosser is not a minor, incapacitated person, officer, or agent of the state of Colorado, or an individual in the military service.
- h. On the basis of reasonable inquiry, Nate Fennell is not a minor, incapacitated person, officer, or agent of the state of Colorado, or an individual in the military service.

i. By failing to respond to Plaintiff's Complaint, the allegations set forth therein are deemed admitted, and, therefore, judgment should be entered in favor of Plaintiff and damages and costs awarded to Plaintiff. As set forth in the Complaint:

i. Tenant occupies the Premises, pursuant to a Lease Agreement, dated November 20, 2020, referenced herein as the "Lease." ... The Rent Commencement Date under the Lease was October 1, 2021.... Plaintiff is the current owner of the Premises and is the landlord under the Lease. The terms of the Lease provide for monthly rent and other amounts payable. Tenant has failed to pay all of the agreed monthly rent and other amounts payable. As a result, the Lease is in default.

ii. On or about November 20, 2020, Defendants Brody King, Carl Crosser, and Nate Fennell ("Guarantors") executed a guarantee of lease ("Guaranty") for performance of all obligations set forth in the Lease....To this date, Guarantors have failed or refused to perform obligations under the Lease, including payments of amounts due. Accordingly, Guarantors are in breach of the Guaranty.

j. Plaintiff fulfilled all of its obligations to Defendants under the terms of the Lease.

5. As of February 2, 2024, Plaintiff's damages consist of:

- a. Unpaid rent and other expenses owed under the Lease through July 1, 2024 in the amount of \$114,364.18.
- b. Repossession expenses for eviction of \$11,375.15.
- c. Expenses associated with locating and installing a replacement tenant of \$248,636.00.

6. Defendants are liable for future rent through July 1, 2024, the date that a new tenant is set to begin to pay rent at the Premises.

7. In addition, Defendants are liable for attorneys' fees and costs pursuant to C.R.S. § 13-40-123 and Paragraph 55 and Exhibit C (Guaranty) of the Lease. Plaintiff has incurred \$9,972.00 in attorneys' fees and \$1,255.91 in costs in this matter through January 23, 2024. The Court finds that the attorneys' fees and costs incurred by Plaintiff are reasonable given the work required.

8. All of the requirements of C.R.C.P. 121 § 1-14 have been satisfied.

9. There is no just reason for delay in the entry of default judgment against Defendants.

Accordingly, the Court ENTERS DEFAULT JUDGMENT in favor of Plaintiff AP 3926-3930 TENNYSON ST., LLC against Defendants Meraki Ventures Highlands LLC, Brody King, Carl Crosser, and Nate Fennell, *jointly and severally*, as follows: in the principal amount of **\$374,375.33**,¹ plus attorneys' fees in the amount of **\$9,972.00**, and plus costs in the amount of **\$1,255.91** for a total judgment of **\$385,603.24**. Post-Judgment interest shall accrue at the rate of eight percent (8%) *per annum*, compounded annually pursuant to C.R.S. § 5-12-102(2).

¹ Unpaid rent and other expenses owed under the Lease in the amount of \$114,364.18 through July 1, 2024, when a new tenant is set to commence paying rent for the Premises, plus repossession expenses for eviction of \$11,375.15, including decommissioning and removal of cryo-therapy machine from the Premises, rekeying, removal of miscellaneous items from the premises, and storage fees, and plus expenses associated with locating and installing a replacement tenant of \$248,636.00, including a tenant improvement allowance and leasing commissions.
