## PARTIAL RELEASE OF EASEMENT

For the sum of ONE DOLLAR (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, QUESTAR GAS COMPANY, A Utah corporation, dba DOMINION ENERGY UTAH, ("Dominion Energy") does hereby release to **Sandy City Corporation**, ("Sandy") the current property owner, its grantees, transferees, heirs, successors and assigns, the rights Dominion Energy holds pursuant to that certain Right-of-Way and Easement Grant dated November 22<sup>nd</sup>, 2006 and recorded as Entry # 9937038, in Book 9393, Page 2276, Salt Lake County Recorder's office (the "Easement").

Dominion Energy only releases the portion of the Easement which is over the property commonly referred to as 9886 S Monroe St, Sandy, UT 84070, Parcel No. 27-12-402-045, in Sandy City, Salt Lake County, Utah, including but not limited to pipelines and related facilities, within the following described tract of land in Salt Lake County, State of Utah, to-wit:


