FINDINGS AND ORDER CREATING

THE UINTAH COUNTY

MOSQUITO ABATEMENT DISTRICT

Pursuant to the provisions of Chapter 14, Title 26, Utah Code Ann. (1953) as amended, a petition having been presented to the Uintah County, Utah Board of County Commissioners praying that a mosquito abatement district be created in and for Uintah County, Utah with its proposed boundaries being the boundaries of Uintah County, Utah.

FINDINGS

The Board of County Commissioners of Uintah County, Utah makes the following findings:

1. The petition presented has been signed by more than ten percent (10%) of the registered voters within the boundaries of the proposed district, who voted in such district for the office of governor at the last general election prior to the presentation of the petition. The petition is genuine and sufficient for the purposes presented.
2. The proposed mosquito abatement district includes all of the City of Vernal, Utah and is signed by more than ten percent (10%) of the qualified electors of said Vernal City.
3. The Vernal City Council, the governing body of Vernal City, has by resolution requested the inclusion of Vernal City in the proposed mosquito abatement district.
4. The text of the petition has been published for at least two weeks before the time when the petition was presented to the Board of County Commissioners together with a notice of the time

of the meeting of the Board of County Commissioners when such petition was presented and that all persons interested therein may then appear and be heard. Said notice was published in accordance with the requirements of the law in the Vernal Express, a newspaper published in Vernal City and Uintah County, Utah.

5. All other requirements of the law for creating a mosquito abatement district in and for Uintah County, Utah, having been fully complied with and the Board of County Commissioners has considered the petition, the comments with reference thereto by interested persons at hearings, and the public necessity and welfare of the proposed mosquito abatement district and the inhabitants thereof.

6. It is in the best interest and welfare of Uintah County, Utah, and the inhabitants thereof that the proposed mosquito abatement district be created and there exists a public necessity for its creation.

ORDER

IT IS HEREBY ORDERED AND DECLARED that a mosquito abatement district in and for Uintah County, Utah, with its boundaries being the boundaries of Uintah County, Utah is hereby created which district shall be named the Uintah County Mosquito Abatement District. This district is created pursuant to the provisions of Chapter 14, Title 26, Utah Code Ann. (1953) as amended and shall have all of the rights, powers, and privileges set forth in said statute and necessarily incident thereto.
