1. Affiant is a citizen of the United States of America, over the age of twenty-one (21) years, and currently resides in Bountiful, Davis County, Utah.
2. By execution of that certain Declaration of Trust dated May 17, 2017, Craig W. Dayhuff created the “*The Craig W. Dayhuff Revocable Trust*” (the “*Trust*”) and served as the sole Trustee of the Trust until his death on January 21, 2025. A certified copy of the death certificate for Craig W. Dayhuff, also known as Craig William Dayhuff, is attached to this Affidavit as *Exhibit “A”*.
3. Under Paragraph 6.1(b) of the Trust, Affiant is nominated to serve as the successor Trustee of the Trust upon the death of Craig W. Dayhuff. Affiant has previously accepted her appointment to serve as successor Trustee of the Trust by execution of that certain Acceptance of Appointment by Successor Trustee.

The Trust is the Grantee of an interest in real property under that certain Limited Warranty Deed recorded on May 19, 2017, as Document Entry No. 12538079, Book 10558, Page 9359-9360 in the office of the Salt Lake County Recorder, State of Utah, as to real property situate in Salt Lake County, Utah (the “*Trust Property*”), more particularly described as follows:

5. The purpose of this Affidavit is thus to acknowledge the death of Craig W. Dayhuff and his removal as Trustee of record of the Trust, and to acknowledge Affiant, Annette D. 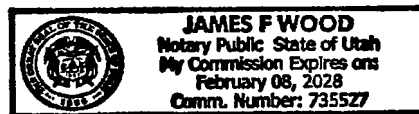
