AMENDMENT

THIS AMENDMENT to the Declaration of Restrictive and Protective Covenants and Conditions of Marrcrest Planned-Unit Development, Provo, Utah is made this 1st day of July, 1971.

IT IS hereby agreed upon by the undersigned, who represent not less than 90% of the Lot owners of Marrcrest Planned-Unit Development, that the aforementioned Declaration of Restrictive and Protective Covenants and Conditions be amended to include and apply to Sections "C", "D", "E", "F", & "G", Marrcrest Planned-Unit Development, and any alterations made within those sections.

THE UNDERSIGNED do further affirm that the following lots within Marrcrest Planned-Unit Development have always been designated as "double lots" and that the intended use of these lots has always been for the purpose of construction of a duplex upon said lots, or a single home on the combination of the two lots.

The following Marrcrest lots fall within the "double lot" or duplex lot category:

Lots 1 & 2, Lots 3 & 4, Lots 5 & 6, Lots 7 & 8, Lots 9 & 10, Lots 11 & 12, Lots 15 & 16, Lots 18 & 19, Lots 20 & 21, and Lots 22 & 23, Section "A", Marrcrest Planned-Unit Development; Lots 30 & 31, Section "B", Marrcrest Planned-Unit Development; Lots 26 & 27, Section "C", Marrcrest Planned-Unit Development; Lots 37 & 38, Lots 40 & 41, and Lots 44 & 45, Section "D", Marrcrest Planned-Unit Development; Lots 50 & 51, Lots 54 & 55, and Lots 57 & 58, Section "F", Marrcrest Planned-Unit Development; and Lots 30 & 31, and Lots 47 & 48, Section "G", Marrcrest Planned-Unit Development.

THE UNDERSIGNED do further affirm that the following lots within Marrcrest Planned-Unit Development have always been designated as a "triple lot" and that the intended use of these lots has always been for the purpose of construction of a triplex upon said lots, or a duplex or a single home on the combination of the three lots. The following Marrcrest lots fall within the "triple lot" or triplex lot category:

Lots 34, 35, & 36, Section "G", Marrcrest Planned-Unit Development.

THE UNDERSIGNED do further affirm that the following lots within Marrcrest Planned-Unit Development have always been designated as lots for 16 townhouse units which have been constructed on these lots. The following Marrcrest lots are those upon which the 16 units were constructed:

Lots 1, 2, 3, 4, 5, 6, 7, 8, 10, 11, 12, 13, 14, 15, 16, & 17, Section "E", Marrcrest Planned-Unit Development.

It should be noted that there were originally 17 lots platted within Section "E", Marrcrest Planned-Unit Development, but that this plat was amended to 16 lots with the "extra" lot reverting to common area with the first 9 lots being converted to 8 lots only.

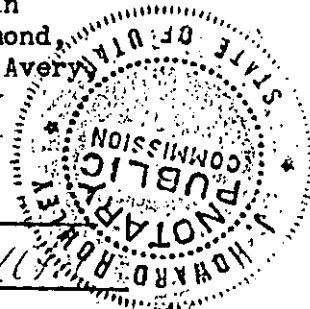

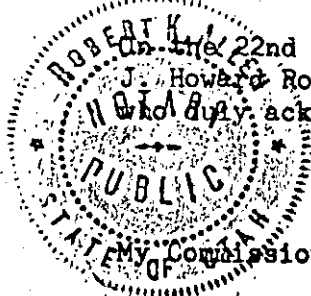
