## GENERAL ASSIGNMENT AND ASSUMPTION OF ROSR

This General Assignment and Assumption of ROSR (this “Assignment”) is executed by WDG Trail Crossing, LLC, a Utah limited liability company (“Assignor”), in favor of CW Trail Crossing, LLC, a Utah limited liability company (“Assignee”), and is consented to by Capstone Acquisitions, Inc., a California corporation (“Capstone”) and Retail’s Daylight LLC, as of March 14, 2025 to be effective at the same time as the Property is transferred to Assignee (the “Effective Date”).

WHEREAS, Assignor is the owner of a parcel of real property identified as Salt Lake County Parcel No. 26-24-353-353-018 (the “Property”);

WHEREAS, Assignor, contemporaneous with this Assignment, is transferring ownership of the Property to Assignee;

WHEREAS, pursuant to that certain Purchase and Sale Agreement and Joint Escrow Instructions between Assignor and Capstone dated September 22, 2023, Capstone has a Right of Second Refusal to purchase the Property of which a Partial Termination of Right of First Refusal was subsequently executed and recorded (the “ROSR”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment. As of the Effective Date, Assignor hereby assigns, sells, and transfers, to Assignee, and Assignee expressly agrees to assume and hereby does assume all of Assignee’s liabilities and obligations pursuant to the ROSR. Notwithstanding the foregoing, this Assignment does *not* release Assignor from any responsibilities to Capstone pursuant to the ROSR. All Parties agree that the original assignment by Capstone to Retail’s Daylight LLC did not include an assignment of the ROSR and that the rights under the ROSR are still held by Capstone. All Parties agree that the transfer of the Property by Assignor to Assignee is not pursuant to a bona fide offer from a third party and does not trigger any rights in Capstone to give an Election Notice and, as a result, the ROSR remains in full force and effect as to the Property.

2. Counterparts. This Assignment may be executed in a number of identical counterparts. Signatures may be delivered by facsimile or electronic delivery, and such signatures shall be binding on the parties hereto, with original signatures to be delivered as soon as reasonably practical thereafter.

3. Applicable Law. This Assignment shall be governed by and interpreted in accordance with the laws of the State of Utah.

4. Binding Effect. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.






