



Beginning at the southwest corner of that Special Warranty Deed recorded January 3, 2002 as Entry No. 8110216 in Book 8550 at Page 6633 in the Salt Lake County Recorder's Office, said point also being N0°45'09" W 1779.84 feet along the Section line and N89°14'51" E 1328.92 feet from the Southwest Corner of Section 33, Township 3 South, Range 2 West, Salt Lake Base and Meridian; thence N00°38'23" W 80.37 feet; thence S85°07'12" E 222.25 feet; thence along the arc of a curve to the right with a radius of 390.00 feet a distance of 62.48 feet through a central angle of 09°10'47" Chord: S80°31'48" E 62.42 feet; thence S75°56'24" E 106.59 feet; thence Southeasterly along the arc of a non-tangent curve to the right having a radius of 390.00 feet (radius bears: S14°03'35" W) a distance of 220.85 feet through a central angle of 32°26'44" Chord: S59°43'03" E 217.91 feet; to a point of reverse curvature; thence along the arc of a curve to the left having a radius of 1,460.00 feet a distance of 395.70 feet through a central angle of 15°31'44" Chord: S51°15'33" E 394.49 feet; to a point of compound curvature; thence along the arc of a curve to the left with a radius of 20.00 feet a distance of 32.17 feet through a central angle of 92°08'57" Chord: N74°54'07" E 28.81 feet; thence S61°10'21" E 68.00 feet; thence Southerly along the arc of a non-tangent curve to the left having a radius of 20.00 feet (radius bears: S61°10'21" E) a distance of 21.00 feet through a central angle of 60°09'06" Chord: S01°14'54" E 20.05 feet; thence Southeasterly along the arc of a non-tangent curve to the left having a radius of 1,457.00 feet (radius bears: N27°05'42" E) a distance of 98.63 feet through a central angle of 03°52'42" Chord: S64°50'39" E 98.61 feet; thence S66°47'00" E 148.06 feet; thence N89°55'34" W 209.54 feet; thence Northwesterly along the arc of a non-tangent curve to the right having a radius of 1,540.00 feet (radius bears: N24°52'36" E) a distance of 581.34 feet through a central angle of 21°37'43" Chord: N54°18'32" W 577.89 feet; to a point of reverse curvature; thence along the arc of a curve to the left having a radius of 310.00 feet a distance of 175.55 feet through a central angle of 32°26'44" Chord: N59°43'03" W 173.21 feet; thence N75°56'25" W 106.59 feet; thence along the arc of a curve to the left with a radius of 310.00 feet a distance of 49.67 feet through a central angle of 09°10'47" Chord: N80°31'48" W 49.61 feet; thence N85°07'12" W 214.52 feet to the point of beginning.
