

**Legal Description of Property**

A Parcel of land located in the Southwest Quarter of the Southwest Quarter of Section 4, Township 1 South, Range 1 West, Salt Lake Base and Meridian, Salt Lake City, Salt Lake County, Utah, more particularly described as follows:

BEGINNING at a point on the southerly line of the 500 South Street right-of-way and the westerly right-of-way of Fulton Street which is 34.77 feet South  $89^{\circ}55'34''$  West along the monument line of 500 South Street and 60.62 feet South  $00^{\circ}04'26''$  East from the monument found marking the intersection of 500 South & Fulton Street (the Basis of Bearings is South  $89^{\circ}55'34''$  West 2547.91 feet measured along 500 South between the monuments found at the intersection of Fulton Street and Gladiola Street), said Point of Beginning is also 32.62 feet South  $00^{\circ}17'26''$  East, more or less, from the Northeast corner of Lot 15, Block 18 in the Buena Vista subdivision recorded December 18, 1888, in Book "B" at Page 6, and running thence South  $00^{\circ}17'41''$  East 601.67 feet along the westerly boundary line of Fulton Street, which is 35.00 feet perpendicularly distant from the monument line thereof, measured as South  $00^{\circ}17'41''$  East 1056.05 feet between said monument at 500 South and the Salt Lake City Brass Cap monument found at the intersection with Loxwood Avenue, more or less, to the Northerly boundary line of the Union Pacific Railroad as described in the Grant of Option recorded in Book 8490 at Page 769 as Entry No. 7976967; thence South  $71^{\circ}36'02''$  West 677.96 feet, more or less, along said railroad and an existing wire fence line to a point on a 4443.96 foot radius curve to the right; thence Westerly 394.91 feet, more or less, along said railroad and the arc of said curve through a central angle of  $05^{\circ}05'29''$  (chord bears South  $73^{\circ}10'13''$  West 394.78 feet) to a non-tangent line; thence North  $00^{\circ}04'26''$  West 947.74 feet, more or less to said southerly right-of-way of 500 South Street; thence along said Street the following two (2) courses, N $89^{\circ}55'34''$ E 1000.22 feet; thence South  $45^{\circ}00'19''$  East 26.98 feet to the POINT OF BEGINNING.
