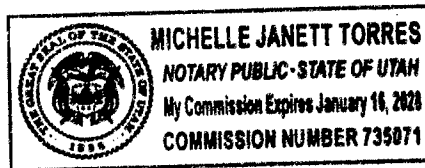

Beginning at the West quarter corner of Section 22, Township 3 South, Range 2 West, Salt Lake Base and Meridian, and running thence South 89°44'03" East 460.16 feet along the quarter section line; thence South 00°05'50" West 496.09 feet; thence South 89°44'22" East 860.00 feet; thence South 00°05'50" West 1,711.39 feet; thence North 89°45'45" West 450.00 feet; thence South 00°05'50" West 405.00 feet to the Northerly right-of-way line of 11800 South Street; thence North 89°45'45" West 1,413.85 feet along said Northerly right-of-way line; thence North 00°14'15" East 10.00 feet; thence South 89°45'45" East 412.93 feet; thence North 00°08'04" East 203.17 feet; thence North 02°52'12" East 485.23 feet; thence Northwesterly 883.66 feet along the arc of a 7,145.00 foot radius curve to the left (center bears North 88°59'11" West and the chord bears North 02°31'46" West 883.10 feet with a central angle of 07°05'10"); thence Northwesterly 796.78 feet along the arc of a 7,355.00 foot radius curve to the right (center bears North 83°55'39" East and the chord bears North 02°58'08" West 796.39 feet with a central angle of 06°12'25"); thence North 00°08'04" East 273.39 feet; thence North 05°36'17" West 100.00 feet; thence North 00°07'36" East 356.41 feet; thence West 534.45 feet to a point on the Easterly right-of-way line of the abandoned "Lark Branch" Railroad; thence North 20°42'12" East 2,089.81 feet along said Easterly right-of-way line to the section line; thence South 00°07'36" West 2,447.03 feet along said section line to the point of beginning.
