I, the undersigned Ronald Storrs as Successor Trustee, do hereby affirm the following:





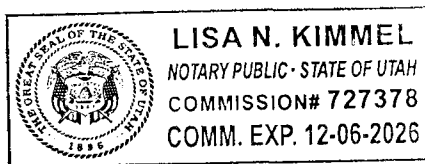
