MEMORANDUM OF LEASE

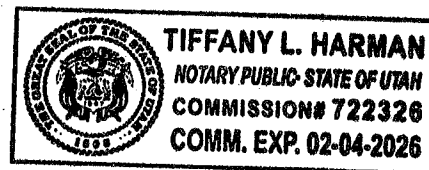

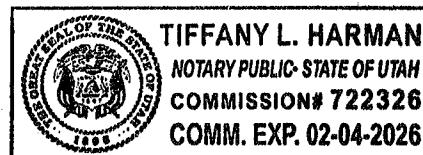
