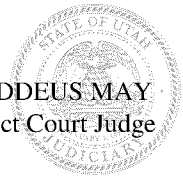

Pursuant to Rule 58A(a) of the Utah Rules of Civil Procedure, the Court hereby enters this Final Declaratory Judgment, adjudging as follows:

1. All claims and the rights and liabilities of all parties in this matter have been adjudicated.
2. This case concerns certain real property consisting of a narrow strip of land located in Salt Lake County, Utah, that is more particularly and correctly described as:

SOUTH 89°57'12" WEST 222.55 FEET AND NORTH 00°02'48" WEST 63.62 FEET FROM A FOUND SALT LAKE CITY STREET MONUMENT BRASS CAP AT 600 NORTH STREET AND 200 WEST STREET, BEING FURTHER DESCRIBED AS WEST 160.5 FEET FROM THE SOUTHEAST CORNER OF SAID LOT 1, AND RUNNING THENCE NORTH 00°02'41" EAST 165.16 FEET, (NORTH 165 FEET BY DEED) TO THE NORTH LINE OF LOT 1; THENCE ALONG SAID NORTH LOT LINE NORTH 89°52'07" EAST 11.99 FEET, (EAST 12 FEET BY DEED); THENCE SOUTH 00°02'41" WEST 165.16 FEET TO THE SOUTH LINE OF LOT 1, (SOUTH 165 FEET BY DEED); THENCE SOUTH 89°52'06" WEST 11.99 FEET, (WEST 12 FEET BY DEED) TO THE POINT OF BEGINNING.

(the “Strip”).

3. **Plaintiff H. Boyd and Associates, L.C. is the sole owner of the Strip, having acquired all right, title, estate, and interest in the Strip by adverse possession by no later than 2020.**

4. Defendants in this case are Neil J. Maude, Danielle Littman, the Unknown Heirs of John B. Soper, Deceased, and All Other Persons Unknown, Claiming Any Right, Title, Estate or Interest in, or Lien Upon the Real Property described in the Pleading Adverse and/or Superior in Priority to Plaintiff’s Interest (collectively, “Defendants”).

5. **Defendants have no right, title, estate, or interest in the Strip, and title to the Strip is quieted in H. Boyd and Associates, L.C. as against all Defendants named herein.**

6. Any claims remaining in the Amended Complaint are dismissed with prejudice.

7. Each party is to bear its own attorney fees and costs in this matter.

8. This *Final Declaratory Judgment* does not affect any public utility easements, if any.

9. This *Final Declaratory Judgment* may be recorded in the Official Records of Salt Lake County, Utah.
