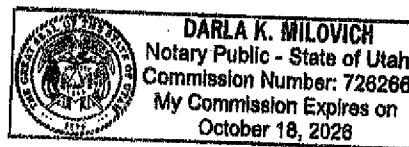

**Legal Description**

A part of the Northeast Quarter of Section 34, Township 3 South, Range 2 West, Salt Lake Base and Meridian, located in Herriman City, Salt Lake County, Utah, being more particularly described as follows:

Beginning at a point located on a southwesterly corner of the Hidden Oaks Subdivision Pod 7 Phase 1 recorded as Entry No. 14007923 in Book 2022P on Page 203 on August 29, 2022, said point also being located N00°10'55"W 3,099.45 feet along the Section line and N89°49'05"E 678.16 feet from the South Quarter Corner of Section 34, Township 3 South, Range 2 West, Salt Lake Base and Meridian; running thence along said subdivision the following two (2) courses: (1) East 100.00 feet; thence (2) South 119.00 feet to the northerly right-of-way of Silver Sky Drive; thence along said right-of-way the following two (2) courses: (1) along the arc of a curve to the right with a radius of 20.00 feet a distance of 20.32 feet through a central angle of 58°12'42" Chord: S29°06'21"W 19.46 feet; thence (2) West 90.54 feet; thence North 136.00 feet to the point of beginning.
