CERTIFICATE OF CITY CHIEF FINANCIAL OFFICER AMENDING ASSESSMENT LIST

The undersigned Chief Financial Officer (the “Authorized Officer”) of the City of South Jordan, Utah (the “City”) hereby certifies with respect to the Daybreak Assessment Area No. 1 (the “Assessment Area”) as follows:

1. The City Council of the City has previously adopted an Amended and Restated Assessment Ordinance on December 4, 2018, amending and restating an Assessment Ordinance adopted by the City Council on December 22, 2015 (the “Assessment Ordinance”).

2. Pursuant to Section 6(d) of the Assessment Ordinance, certain parcels within the Assessment Area have been subdivided and it is necessary to make changes to the parcels including, without limitation, reducing or increasing the size of the parcels, modifying the boundary description of the parcels, to otherwise make changes necessary or appropriate to plat the parcels, to modify the assessment area classification of that parcel, or re-allocate ERUs among parcels within such Assessment Area classification. Furthermore, certain parcels within the Assessment Area have fully paid off the Assessment associated with that parcel and the Assessment Liens on such parcels have been released. Accordingly, the amended Assessment List is attached hereto as Exhibit A and the required notices are hereby authorized to be recorded.

The amendment to the Assessment List does not increase the size of a parcel or change the boundaries of the Assessment Area.




