


EXHIBIT A

Beginning at a point on the Westerly right of way line of Fulton Street, which is 34.77 feet South $89^{\circ}55'34''$ West along the monument line of 500 South Street and 60.62 feet South $00^{\circ}04'26''$ East and 298.42 feet South $00^{\circ}17'41''$ East from the street monument marking the intersection of said 500 South Street and Fulton Street, said point also being 32.62 feet South $00^{\circ}17'26''$ East and 298.42 feet South $00^{\circ}17'41''$ East from the Northeast corner of Lot 15, Block 18, Buena Vista Subdivision recorded December 18, 1888 in Book "B" at Page 6 in the office of the Salt Lake County Recorder; thence South $00^{\circ}17'41''$ East 39.96 feet along said Westerly right-of-way line of Fulton Street; thence South $89^{\circ}42'55''$ West 43.15 feet; thence South $74^{\circ}50'48''$ West 222.49 feet; thence South $76^{\circ}03'30''$ West 129.13 feet; thence North 127.47 feet North $89^{\circ}42'19''$ East 383.03 feet to the point of beginning.
