MEMORANDUM OF REVOCABLE PERMIT AGREEMENT

Notice is hereby given of that certain Revocable Permit Agreement (the "Permit") made effective as of December 23, 2025 (the "Effective Date") between SALT LAKE CITY CORPORATION, 451 South State Street, Rm. 425, Salt Lake City, Utah, (the "City") and 1000 E SUGARHOUSE APARTMENTS, LLC, a Delaware Limited Liability Company, (the "Permittee"), on file with the Salt Lake City Recorder's office.

For the consideration set forth in the Permit, City has granted a license to Permittee to encroach on the City's real property adjacent to the Owner's property described below (the "Property") by maintaining the following in the public right of way (the "Improvements"): *Two gate swings for transformer gear enclosures occupying 33 sq ft of right of way on 1000 East and 73 sq ft on Lincoln St*

The term of this Permit is for ten (10) years commencing on the Effective Date, which may be extended by agreement between the City, Owner, and Permittee. The Permit is non-transferable, and revocable by City.

The Permit affects the Property located at 2141 S 1000 E, Salt Lake City, Utah, Parcel No. 16-20-136-005, 16-20-136-006, 16-20-136-010, 16-20-136-011, 16-20-136-012 and 16-20-136-013, more particularly described as follows:


