AMENDMENT TO RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS:

Whereas the undersigned, Bonnie Development Company, a co-partnership, duly organized and existing under the laws of the State of Utah, did on or about the 15th day of August 1955 execute those certain restrictive covenants recorded in the office of the Salt Lake County Recorder in Book 1258 at page 229 as Entry No. 11,56070, reference to which is hereby made. And whereas it is the desire of the undersigned to amend paragraph "E" of said restrictions, NOW THEREFORE, the undersigned does hereby declare that said paragraph "E" is amended to read as follows:

"e" "No building shall be erected on any lot until the design and location thereof have been approved in writing by said committee. In any case, no dwelling shall be permitted in said tract with the ground floor square foot area of less than 1500 feet, if the structure contains an attached garage, nor less than 1700 feet if the structure does not conattached garage, nor less than 1700 leet it he structure does not contain an attached garage, provided, however, that with respect to lots 701 to 705, inclusive, 707, to 711, inclusive, lots 712, 719, 720, 731, and 732, no dwelling shall be permitted with the ground floor square area of less than 1250 feet if the structure includes an attached garage or 1350 feet without such attached garage. No lot shall be resubdivided, nor shall any dwelling be placed on any lot having a width of less than 100 feet at the mimimum building setback line or an area of less than 10,000 square feet."

Except as hereinabove mentioned, said restrictions shall remain in full force and effect.
