CERTIFICATE RESPECTING RIGHT OF WAY

WHEREAS under date of July 18, 1949, Ellis D. Field and Emily West Field executed and delivered to Salt Lake Pipe Line Company a grant of right of way, which was recorded July 27, 1949 in Book 5, page 95 of Official Records of Davis County, State of Utah, and

WHEREAS said grant of right of way covered a part of the Southeast Quarter of Section 26, Township 5 North, Range 2 West, Salt Lake Meridian, which said portion of said quarter section has now been platted into a subdivision designated as BUENA VISTA SUBDIVISION NO. 3, and said grant of right of way affects Lots 1 to 95 inclusive of said subdivision, and

WHEREAS request has been made to Salt Lake Pipe Line Company to identify the location of its right of way within said subdivision and to relinquish any claim of right of way to premises not affected by said right of way as located and established on the ground.

NOW THEREFORE for such purpose said Salt Lake Pipe Line Company, a corporation, does hereby certify that the right of way, held and enjoyed by it under said grant, as now located and established upon the ground, is confined to a strip of land lying within the westerly 50 feet of said subdivision, said strip being designated as Sequoia Drive on the plat of said subdivision recorded in Book "P" of "L&L", page 212, Records of Davis County, Utah. In addition Salt Lake Pipe Line Company reserves the right to use the other dedicated streets of said subdivision for ingress to and egress from its pipe lines and right of way within Sequoia Drive. Said Salt Lake Pipe Line Company hereby releases and relinquishes any right or interest in or to any lots in said BUENA VISTA SUBDIVISION NO. 3.

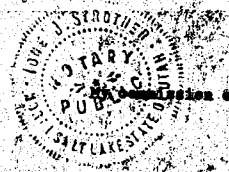
