Soderby, LLC, a Utah limited liability company, Grantor, hereby CONVEY AND WARRANT to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 S. 2700 W., Salt Lake City, Utah 84119, Grantee, for the sum of TEN (\$10.00) Dollars, and other good and valuable considerations, the following described parcel of land in Morgan County, State of Utah, to-wit:

A parcel of land in fee for the purpose of acquiring right of way for Mtn. Green Interchange at SR-167 and I-84 known as Project No. S-0167(7)2, being part of an entire tract of property situate in the SE1/4 NE1/4 of Section 26, T. 5 N, R. 1 E, S.L.B.&M. in Morgan County, State of Utah. The boundaries of said parcel of land are described as follows:

Beginning at a northeasterly property corner of said entire tract, which point lies 536.80 feet N.00°10'15"E. along the section line and 698.11 feet N.89°49'45"W. from the East Quarter corner of said Section 26, said point being 135.25 feet perpendicularly distant easterly from the control line of said project, opposite Engineer Station 2+86.88; and running thence S.02°04'45"E. 122.47 feet along an easterly line of said entire tract; thence S.27°52'42"W. 32.53 feet to a point 75.02 feet perpendicularly distant easterly from the control line of said project, opposite Engineer Station 4+46.38; thence northerly 157.56 feet along the arc of an 758.21 foot radius non tangent curve to the right (Note: Chord to said curve bears N.18°45'53"W. 157.27 feet. Central angle equals 11°54'22") to a northerly line of said entire tract; thence N.87°55'15"E. 61.40 feet along said northerly line to the Point of Beginning.


